1. DOC-2018-86 Northside Final Plat Approval

This entire block was the original school property and has been re-purposed very successfully for various civic purposes including a multi-purpose educational facility with meeting rooms, computer lab, and City Development Corporation offices. Northside Center Inc. is a quasi-governmental board with City and School control.

The need for replat is due to the request from the Boys & Girls Club to deed the property they use to them so that Boys & Girls Club could continue to get grant funding for the facilities. Currently the property has been deeded to different entities and in different configurations. The property was previously deeded to the Heritage Center and prior to that to the County for a library, while the school still retains some of it. The city has been working on the plat configuration with the surveyor and the attorney. This replat will ensure that the subdivision regulations are followed, and parcels are separated as per individual deeds by a replat. To address shared parking and utilities, parking and utility easement agreements have been drafted. Since the approved replat needs to be referenced in these agreements, the agreements will be finalized once the replat is approved.

Since the plat boundaries are dictated by existing buildings, some variances are required to be approved during the platting process by the Planning and Zoning Commission and the City Council. For example, the proposed lot lines do not show 10' parking setback for parking lots. A variance for reduced setback would be needed to approve the plat as shown for lots 2A, 4A,5A,7A,8A. Additionally, one of the parcels would need access from an alley. Approval of variances for setbacks and access for the proposed replat application of Northside Health Center Inc., DBA Northside Center Inc. to replat 3.2158 acres of land described as Lots 8-14, Block 13 and El Campo High School Block of Duson Addition, generally located north of Church Street, east of Depot Street, south of W. Norris Street, and west of Fahrenthold Street.

Staff recommends that the required variances for setbacks, access, and number of parking spaces be approved as shown with the following condition:

Add a note on the replat that variances for setbacks, access, and parking spaces are approved as shown on

the replat.

Planning and Zoning approved the plat at their September 27, 2018 meeting.

#### 2. The Basics Community Campaign Presentation by ECISD Superintendent Kelly Waters

A presentation will be presented by Mrs. Waters to share the following message:

The Basics are five evidence-based parenting and caregiving principles that encompass much of what experts find is important for children from birth to age three. Every child from every background can benefit from routinely experiencing the Basics learning experiences. Therefore, I would like to start a community campaign by working through the city, hospital, churches, and daycares to ensure that every parent and caregiver is fully supported by family and friends to use the Basics practices in everyday life.

El Campo Independent School District Superintendent Kelly Waters gave a brief presentation and stated that her goal is to get the information on The Basics Partner Orientation and Training out to the people. She has tool kits that includes videos, posters and flyers. Superintendent Waters is seeking additional organizations to share this information with, if there is a church, service organization or a day care that someone has a connection with that could help her share this program information with them and implement this program at their facility.

#### RESULT: NO ACTION REQUIRED

#### 3. Resolution No. R2018-14 AEP LED Pilot Program

Included in the packet is Resolution No. R2018-14, providing support to AEP's LED Pilot Program. The Pilot Program is only available to cities, government agencies, colleges, universities and certain institutions for LED street lighting fixtures installed upon request for the purpose of illuminating public streets, highways and parking lots. Existing lights will be retrofitted, in phases to LED lighting. Staff recommends retrofitting the lighting on the main corridors (Jackson Street and Mechanic Street) first, then phasing in remaining street lights.

The City currently has 853 lights, of which 835 are high pressure sodium lights and 18 are mercury vapor lamps. Almost half of the inventory are 100 watts, and will after this program is complete, be 41 watts. The first phase includes 111 lamps on Jackson and Mechanic, the cost to replace these is \$137.70 a lamp or \$15,284.70, which will take multiple fiscal years to complete. This phase will save the City \$2,000 annually. The total project, when complete, is projected to offer a savings of over \$7,500 annually for these lamps.

Also included in the packet is an image of the proposed lighting.

Vee Strauss, with AEP, will be present to answer any questions regarding lighting, the Resolution or other concerns.

This Resolution allows AEP to amend their tariffs to support the rates in Exhibit A. Staff recommends approval of Resolution No. R2018-14.

## Ordinance No. 2018-24 Commercial Vehicles - Designated Routes

Ordinance No. 2018-24 amends Chapter 12, Section 12.04 "Commercial Vehicles," replacing it with a new section 12.04. This Ordinance designates truck routes and exceptions inside the city limits and has been in the works internally for a while now as it needed to be updated.

The proposed Ordinance has been reviewed and is recommended by staff for an initial discussion and can be modified if desired or proceed to adoption.

### CITY OF EL CAMPO, TEXAS ORDINANCE NO. 2018-24

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF EL CAMPO, TEXAS, CHAPTER 12, SECTION 12.04 "COMMERCIAL VEHICLES", BY REPEALING ALL OF THE EXISTING SECTION 12.04 AND REPLACING IT WITH A NEW SECTION 12.04, PROVIDING FOR DEFINITIONS, DESIGNATED ROUTES, COMPLIANCE, AND EXCEPTIONS FOR COMMERCIAL VEHICLES; PROVIDING FOR A PENALTY IN AN AMOUNT OF NOT MORE THAN TWO HUNDRED DOLLARS (\$200.00) FOR VIOLATION OF ANY PROVISIONS HEREOF BY INCLUSION INTO THE CODE; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR NOTICE BY PUBLICATION.

#### **PREAMBLE**

**WHEREAS**, the City Council for the City of El Campo, Texas ("the City") finds that streets are designed and built to handle specific types of vehicular traffic; and

**WHEREAS**, the City finds that commercial vehicles, due to their size and weight can cause damage to streets that are not designed for commercial traffic; and

**WHEREAS**, the City further finds that the operation of commercial vehicles in certain areas of the City not designed for commercial vehicle traffic pose additional risks to the health, safety and welfare of the public; and

**WHEREAS**, the City Council of the City of El Campo, Texas has determined that in the interest of safety and in the interest of protecting tax revenue investments in city streets, it is necessary to regulate and establish designated truck routes on public streets and highways in the corporate limits of El Campo, Texas pursuant to the rules, regulations and limitations imposed by law;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL CAMPO, TEXAS, THAT:

#### SECTION 1. FINDINGS OF FACT.

The facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct.

#### SECTION 2. AMENDMENT TO THE CODE.

The El Campo City Code of Ordinances, Chapter 12, "Traffic and Vehicles", is hereby amended by replacing the existing Article 12.04, entitled "Commercial Vehicles" with the following in its place, to wit:

#### **Article 12.04 - Commercial Vehicles**

#### Sec. 12.04.01. Definitions.

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

City means the all areas included within the corporate city limits of the City of El Campo, Texas.

Commercial vehicle means any vehicle, with a manufacturers gross vehicle weight rating in excess of 10,000 pounds or carrying capacity exceeding one ton and used for the delivery of passengers, tools, materials, or livestock. A "Recreational vehicle", herein, is not considered a commercial vehicle.

**Recreation vehicle** means personal vehicles such as boats and boat trailers, watercraft and watercraft trailers, travel trailers, pickup campers or coaches (designed to be mounted on automotive vehicles), motorized dwellings, tent trailers and the like, and all-terrain vehicles.

*Trailer* means a device without motive power designed for carrying persons, animals, or property on its own structure and to be drawn by a vehicle with motive power. The term shall include, but not be limited to, semitrailer, utility trailer, travel trailer and boat trailer.

Truck means a "commercial vehicle."

Truck routes mean those routes which are designated in this article for the use of truck traffic.

*Truck traffic* means the operation of any commercial vehicle including but not limited to truck, truck tractor or combination of any truck, truck tractor, trailer, or semitrailer that are considered commercial vehicles. The operations of "recreational vehicles" are not considered to be truck traffic.

*Vehicle* means every device in, upon, or by which any person or property is or may be transported or drawn upon a street or road including devices moved by an engine, a motor, a motor vehicle or by human or animal power. Vehicle includes a trailer. Devices used exclusively upon stationary rails or tracks are not considered vehicles.

#### Sec. 12.04.02. Compliance.

No person shall operate truck traffic upon any roads, avenues, streets or thoroughfares within the city, except on those which are designated as truck routes in section 12.04.03, with the exceptions as set forth in sections 12.04.04 and 12.04.05.

#### Sec. 12.04.03. Designated Routes.

For the purposes of this article, the following streets and thoroughfares within the city are designated as truck routes:

U.S. Highway 59; U.S. Highway Business 59; State Highway 71; Farm to Market Roads Numbers 2765, 1162, 1163 & 653.

#### Sec. 12.04.04. Proceeding Directly to Routes.

If any truck traffic originating within the city shall have, as its point of origin, a point located off a designated truck route, it shall proceed to the nearest point on a designated truck route by the most direct route as possible. If such traffic shall originate outside the city and enter the city at a point which is not on a designated truck route, it shall proceed to the nearest point on a designated truck route by the most direct route possible.

#### Sect.12.04.05. Departing from Routes.

- Truck traffic restricted to the streets designated as truck routes may depart from such truck routes, where it is necessary for the immediate loading or unloading of property at locations situated off designated truck routes. However, such truck traffic shall not leave any designated truck route until it has reached a point on some designated truck route which is nearest the applicable place of loading or unloading by the most direct route possible. After leaving a designated truck route to load or unload, truck traffic may continue off truck routes to as many points of destination as necessary. However, if in the course of making necessary stops for loading and unloading the truck traffic shall cross a designated truck route, the truck traffic shall not again leave any designated truck route until it has reached a point on some designated truck route which is nearest to the next place of loading and unloading by the most direct route possible.
- (2) When, under section 12.04.04, truck traffic originates off a designated truck route, whether inside or outside the city, and the destination of the truck traffic is nearer the origin or point of entering the city, as the case may be, than is the nearest point on a designated truck route by the most direct route possible, it shall not be necessary to proceed to the nearest designated truck route.
- (3) Driving to a place of business in a commercially zoned area shall be a defense for driving on a non- truck route.
- (4) The City Manager may cause to be erected signs upon the streets which are not truck routes, which signs shall be the type to conform to the Manual on Uniform Traffic Control Devices.
- (5) The City Manager may cause to be erected signs upon the streets to direct trucks to truck routes, which signs shall be the type to conform to the Manual on Uniform Traffic Control Devices.
- (6) When a street or roadway designated as a truck route is under repair or otherwise temporarily out of use, the City Manager is authorized to designate alternate truck routes.

#### Sec. 12.04.06. Justification of departure.

A person operating any commercial vehicle including but not limited to truck, truck tractor or combination of any truck, truck tractor, trailer, or which is not designated as a truck route by this article shall have in his possession for the inspection of police officers or other law enforcement personnel his log book, delivery slips or other evidence of his destination and point of origin to justify the presence of the vehicle on a street or roadway other than a designated truck route.

#### Sec. 12.04.07. Exceptions to Section 12.04.05.

(l) Emergency vehicles.

- (2) Vehicles operated by a public utility while operating in an assigned area for the purpose of inspecting the facilities of the public utility and/or providing maintenance service to such facilities.
- (3) Municipal and county vehicles and/or their duly authorized contractors performing city and county business and services, school buses and church buses.

#### SECTION 3. PENALTY CLAUSE; INCLUSION INTO THE CODE.

This Ordinance is hereby incorporated into and made a part of the City of El Campo Code of Ordinances. Any person who shall violate any provision of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction, shall be fined in an amount not more than Two Hundred Dollars (\$200.00) per offense or the maximum amount permitted by law. Each day of violation shall constitute a separate offense.

#### SECTION 4. REPEAL OF CONFLICTING ORDINANCES.

All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

#### **SECTION 5. SEVERABILITY.**

In the event any clause, phrase, provision, sentence, or any part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City Of El Campo, Texas, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

#### SECTION 6. NOTICE BY PUBLICATION

The City Secretary shall give notice of the enactment of this Ordinance by promptly publishing it or its descriptive caption and penalty after final passage in the official newspaper of the City. This Ordinance shall take effect ten day after the date of such publication.

#### **SECTION 7. OPEN MEETING COMPLIANCE**

It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public as required by law and that public notice of the time, place and purpose of said meeting was given as required by the Texas Open Meetings Act, Texas Government Code, Chapter 551.

### Ordinance No. 2018-25 On-Street Parking

Included in the packet is Ordinance No. 2018-25 which adds additional sections to the Code of Ordinances to prohibit on-street parking of oversized and commercial vehicles in residential districts. This includes all oversized vehicles, trailers, boats and boat trailers which create traffic hazards and safety issues when parked on streets and roadways in residential neighborhoods and was prompted through the process of reviewing the truck ordinance.

### CITY OF EL CAMPO, TEXAS ORDINANCE NO. 2018-25

AN ORDINANCE AMENDING "TRAFFIC AND VEHICLES", ARTICLE 12.03 "PARKING" BY ADDING SECTIONS TO THE CODE OF ORDINANCES OF THE CITY OF EL CAMPO, TEXAS TO PROHIBIT ON-STREET PARKING OF OVERSIZE AND COMMERCIAL VEHICLES IN RESIDENTIAL DISTRICTS; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING A SAVINGS CLAUSE; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR AN EFFECTIVE DATE; PROVIDING FOR A PENALTY; AND PROVIDING FOR NOTICE BY PUBLICATION.

#### **PREAMBLE**

**WHEREAS**, the City Council of the City of El Campo, Texas ("the City") finds that certain commercial and oversized vehicles, trailers, boats and boat trailers create traffic hazards and safety issues when parked on streets and roadways in residential neighborhoods; and

WHEREAS, the City finds that such commercial and oversized vehicles, boats and boat trailers due to their size can also create obstacles to pedestrian and bicycle traffic in such residential neighborhoods thereby damaging the quality of life of its citizens as well as causing unsightly and unwanted visual detractions to such neighborhoods; and

WHEREAS, the City Council of the City of El Campo, Texas has determined that in the interest of safety and in the interest of protecting the residential citizens use and enjoyment of city streets and roadways and preserving and protecting the visual enjoyment of such neighborhoods, it is necessary to regulate and prohibit certain vehicles and trailers from parking on public streets and roadways within the corporate limits of El Campo, Texas pursuant to the rules, regulations and limitations imposed by law;

### NOW, THERFORE, BE IT ORDAINED BY THE CITY OF EL CAMPO, TEXAS THAT:

#### **Section 1. Findings of Fact.**

The facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct.

**Section 2**. **Amendment to the Code.** That Chapter 12, Article 12.03 "Parking" of the Code of Ordinances of the City of El Campo, Texas is amended to add the following sections to read as follows:

#### **Sec. 12.003.03. Definitions.**

For the purposes of this Article 12.03 the following words and phrases shall have the meanings respectively ascribed to them by this section:

*Alley* shall mean land dedicated to public use and devoted to secondary access to lots.

Boat trailer shall mean a trailer and/or semi-trailer which is designed and constructed to carry a sailboat, motorboat or other vessel used upon any body of water.

*Bus* shall mean every motor vehicle designed for carrying more than ten (10) passengers and used for the transportation of persons and ever motor vehicle other than a taxicab designed and used for the transportation of persons for compensation.

Commercial Vehicle shall mean a bus, semi-trailer, truck, truck tractor, house trailer, farm tractor or implement of husbandry.

*Driveway, private,* shall mean any entrance or exit over the sidewalk or sidewalk area of any street affording a means of ingress or egress for vehicles to or from any private property.

House trailer, travel trailer shall mean a trailer or semi-trailer which is designed, constructed and equipped as a dwelling place living abode or sleeping place (either permanently or temporarily) and is equipped for use as a conveyance on streets and highways, and shall include those vehicles commonly known as recreational vehicles.

*Implement of husbandry* shall mean every vehicle designed and adapted for use as a farm implement machinery or tool as used in tilling the soil but shall not include any passenger car or truck.

Loading zone shall mean that portion of any roadway set apart, marked and numbered for the sole use or the public as a place for loading or unloading passengers, merchandise or other cargo.

*Motor home* shall mean every vehicle designed and constructed as a dwelling place, living abode or sleeping place (either permanently or temporarily) and equipped for use as a conveyance on streets and highways.

Motor vehicle shall mean every vehicle which is self-propelled.

Oversize Vehicle shall mean a motor home, any motor vehicle or trailer that exceeds twenty (20) linear feet, or any commercial motor vehicle with a rated gross weighted capacity of in excess of one and one-half (1 ½) tons according to the manufacturer's classification.

*Park, parking* shall mean the standing of a vehicle, whether occupied or not, other than temporarily for the purpose of and while actually engaged in loading or unloading merchandise or passengers.

Semitrailer shall mean every vehicle without motor power, designed for carrying persons or property and for being drawn by a motor vehicle and so constructed that some part of its weight and that of its load rests upon or is carried by another vehicle.

Street, roadway and highway shall mean the entire width between the boundary lines of every way publicly maintained when any part thereof is open to the use of the public for purpose of vehicular and pedestrian travel.

*Trailer* shall mean every vehicle without motor power, designed for carrying persons or property and for being drawn by a motor vehicle and so constructed that no art of its weight rests upon the towing vehicle.

*Truck tractor* shall mean every motor vehicle designed and used primarily for drawing other vehicles and not so constructed as to can a load other than a part of the weight of the vehicle and load so drawn.

Whenever any words and phrases used in this chapter arc not defined in this chapter, but are defined in the state laws regulating the operation of vehicle, any such definition therein shall be deemed to apply to such words and phrases used in this chapter.

### Sec. 12.03.004. Parking of Oversize and Commercial Vehicles, Trailers, Boats, or Boat Trailers Prohibited on Streets in Residential Districts.

(a) It shall be unlawful for any person to park or stand a commercial vehicle, oversize vehicle, trailer, semi-trailer, boat, or boat trailer or to allow such to park or stand upon any public street, highway, alley, sidewalk or public right-of-way between any street and alley, within any part of the city classified by the zoning ordinance of the city as a Single-family residence district, two-family and attached single-family residence district, multiple-family district, or multiple-family residence district (being zoning designations R-1E, R-1, R-1S, R-1M, R-2 and R-3).

- (b) It is an affirmative defense to this section that the vehicles or trailers defined in Section
- (a) herein are:
  - 1. In the act of loading. or unloading passengers, freight, or merchandise;
  - <u>2.</u> Publicly owned or franchised emergency or utility vehicles carrying out official duties;
  - 3. Being used for street construction, maintenance, or repair;

- 4. Suffering with a mechanical defect, making it unsafe to proceed further, in which event it shall be lawful to stand or park the vehicle during the time necessary to make emergency repairs:
- <u>5.</u> Any motor home, boat, boat trailer, trailer or house trailer being loaded, unloaded, or otherwise prepared for use or storage during a period of time that does not exceed five (5) hours; or
- <u>6.</u> Owned or operated by a contractor who has parked the vehicle in front of a residence or residential lot for which the person is contracted to do work, provided that the vehicle is parked only between the hours of 7:00 a.m. and 8:00 p.m. and only while the work is being performed.
- <u>7.</u> Vehicles defined herein as recreational travel trailers, motor homes, boats and boat trailers that are parked for less than a twelve (12) hour period in anticipation of immediate use and being move therefrom within such time period.

**Section 2.** That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

- **Section 3.** That if any provision of this ordinance shall be held to be invalid or unconstitutional, the remainder of such ordinance shall continue in full force and effect the same as if such invalid or unconstitutional provision had never been a part hereof.
- **Section 4.** That it is the intention of the City Council and is hereby ordained that the provisions of this ordinance shall become and be a part of the Code of Ordinances of the City of El Campo, Texas and that sections of this ordinance may be renumbered or re-lettered to accomplish such intention.
- **Section 5.** That a violation of this ordinance shall be a Class C misdemeanor and the penalty for violating this ordinance shall be as provided for in Sec.1.01.009 of the Code of Ordinances of the City of El Campo, which shall be a fine of not less than one dollar (\$1.00) and no more than five hundred dollars (\$500.00), and each day a violation exists shall be a separate offense.
  - **Section 6.** That this ordinance shall take effect on November 1<sup>st</sup>, 2018.
- **Section 7.** That it is hereby officially found and determined that the meeting at which this ordinance is passed is open to the public and that public, notice of the time, place, and purpose of said meeting was given as required by law.
