## 6. CONSIDERATION OF AND ACTION ON

### 1. DOC-2018-8 FY17 Audit

Todd Pruitt, Partner with Patillo, Brown and Hill, LLP will present the FY17 Audit.

The audit was reviewed by the Finance Committee with staff and Mr. Pruitt on Tuesday, February 20, 2018 and all recommend adoption as presented.

Paul O'Leary, FY17 Audit Supervisor, with Pattillo, Brown and Hill presented an overview of the Independent Auditors Report (Opinion Letter) and Government Auditing Standards Report. An un-modified opinion, commonly referred to as a clean opinion, was issued and is the highest opinion that can be given. The Government Auditing Standards report states there are no significant deficiencies or material weakness.

### 2. DOC-2018-9 Award Contract for Engineering of Water and Sewer Line Extension

Staff solicited proposals for engineering of water and sewer line extension; and lift station to the proposed RV Park. Proposals were due on February 8, 2018. Staff received 7 proposals, from the following firms: Jones Carter, Urban Engineering, KSA, TGB Group, BEFCO Engineering, Brinkley and Barfield Consultant Engineers, and FSC Inc.

Courtney Sladek and Jerry Lewis completed evaluations on the proposals and recommend BEFCO. This firm has extensive background in designing and implementing these types of projects. Attached is the engineering agreement and the scope of work, totaling \$156,000 and includes engineering services for the following:

1. Extend new waterline approximately 6,100 linear feet from the existing 12-inch waterline located on the south side of East Jackson Street to the south side of CR 451
2. Construct new sanitary sewer lift station
3. Construct approximately 2500 linear feet of sanitary sewer force main from the new lift station west
4. Construct approximately 5450 linear feet of gravity sanitary sewer line from the new lift station north to the south side of CR 451

Mayor Pro-Tem Young made the MOTION to approve as amended the Contract for Engineering of Water and Sewer Line Extension to BEFCO Engineering, Inc. and Council Member Allgayer Seconded.

### 3. DOC-2018-10 Award of the Tres Palacios Creek Project bid

This project has been in the works since the initial application in 2010 and is finally at the point of moving forward despite many obstacles along the way. Halff has prepared a memorandum which provides the story of how we got to this point and is actually the support for the request that was submitted to Kathy Hopkins at TWDB to revise the scope/budget. Only two bids were received this time and the cost went up as anticipated due to workloads being heavier and the contractor having to secure sites for removal of the spoils. The current extension will expire this September 2018 but the request also includes a request to extend that to the final contract date of September 2019.

The Comprehensive Plan Committee that had reviewed the bids previously was the go to for review and discussion with the exclusion of Jeff Allgayer since DAM had bid on previous attempts but did not submit a bid this time. Mayor Collins and Mayor Pro-Tem Young both agreed along with staff that the recommendation prepared by Halff that is attached is the direction to take.

Kathy Hopkins intends to submit a letter stating that the request has been forwarded to FEMA for their approval and that will be provided at the meeting.

The recommendation is to award the bid to Challenger Services, Inc. with the low bid of \$4,242,498.31 contingent upon approval of the amendment for additional funding so that work can proceed as soon as that is received.

Mayor Pro-Tem Young made the MOTION to award the Tres Palacios Creek Channel Improvement Project to Challenger Services, Inc. in the amount of four million two hundred forty two thousand four hundred ninety eight dollars and thirty one cents (\$4,242,498.31) contingent upon budget amendment approval from FEMA and that the late submission of financial statements by low bidder, did not impact the award and Council Member Hitzfeld Seconded.
